

ADVISORY TO REGISTERED MEDICAL PRACTITIONERS

As per the direction of Additional Chief Secretary to Govt. of Haryana, Health Department vide letter no. 2PM(COVID)/2020/3467-3666 Dated-05/04/2020. The Private Physicians/Practitioners shall intimate Health Department through concerned Civil Surgeon regarding each and every suspected case referred for COVID-19 testing for which sample has been sent to the private labs with details as mentioned below and similarly intimate each positive test for COVID-19 case.

This advisory is issued to all registered medical practitioners in Gurugram. The Government has decided below mentioned designated so far 06 Private Labs for the testing of COVID-19 cases.

1. **Strand Life Sciences**, A-17, Sector 34, Gurugram
2. **SRL Limited**, GP26, Sector 18, Gurugram
3. **Core Diagnostic Pvt. Ltd.**, Udyog Vihar, Phase-3, Gurugram
4. **MoIQ Laboratory**, Plot No 28, 29, Sector 18 (P), Electronic City, Udyog Vihar, Phase IV, Gurugram
5. **Modern Diagnostic and Research Centre-Lab**, 363-364/4, Jawahar Nagar, Gurugram
6. **Pathkind Diagnostics Pvt. Ltd**, Plot 55-56, Phase 4, Udyog Vihar Sector 18, Gurugram

The above said labs are **not allowed** to collect any sample for testing unless accompanied by a **valid prescription and ICMR referral form for COVID-19 (SARS-CoV2)** from a Registered Medical Practitioner.

All Registered Medical Practitioners are hereby advised the following:

The prescriptions for Covid-19 cases should only be issued by a Registered Medical Practitioner, who is defined as a person who is enrolled in the State Medical Council or Medical Council of India by rules.

The Prescription for Covid-19 case testing should **only** be issued as per ICMR guidelines (www.icmr.nic.in) for testing.

The prescription issued by the Practitioners/Physicians must include the following details of the patient and notify on <https://onemapggm.gmda.gov.in/hrheal> ; Helpline no +918047107709. All the Practitioners must get themselves registered on this portal latest by 11 Apr 2020 mandatorily.

Patient's full name, age, gender; Patient's phone number; Patient's full residential address in Gurugram; Symptoms displayed by the patient.

Any violation of these directions shall be punishable under epidemic act.
